You are encouraged to make your quotation competitive. You are also cautioned against any collusion with other potential offerors regarding price. The RFQ does not commit the American Embassy to make any award. The Embassy may cancel this RFQ or any part of it.

Quotations are due by **April 28, 2022, at 16:00** (Algiers time).

SECTION 1 - THE SCHEDULE

The Contractor shall perform standard garbage removal services for the U.S. Embassy Algiers, during one (1) year and four (4)- One (1) option years, until the May 15, 2027.

I.1 PRICING AND PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price Contract is for the Garbage **removal services at the U.S. Embassy algiers chancery and the residential units leased by the U.S. Embassy Algiers in the following areas: Ben Aknoun, El Biar, El Mouradia, and Hydra.** in accordance with Attachment A- *Scope of work*.
- B. The contract will be for a one-year period from the date of the contract award, with four one-year options.

The Government will pay the Contractor a fixed price per month for the delivery of garbage removal services, heretofore referred to as Standard Services, on a unit basis for residences in any of the four areas listed above. The per unit cost is understood to mean garbage removal from any one residential unit in any of the four listed areas. Proposals shall include the cost of all labor, materials, equipment, services, insurance (see FAR 52.228-3 and 52.228-5), overhead, and profit. A residential unit is defined as a single-family dwelling. Many US Embassy Algiers leased properties have several residential units at the same address.

The number of residential units, and their location, will vary over time as the Embassy adjusts its housing pool. The Standard Services will be increased over time, beginning with a minimum of 60 units and up to a maximum of 65 units. The fixed unit price for Standard Services will apply to all residential units in the four areas listed regardless of location.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed (NTP). The NTP will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start. The number and location of residential units that will receive Standard Services will be defined at NTP and will be adjusted periodically as necessary.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months, with four one-year options to renew. The initial period of performance includes any transition period authorized under the contract.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. **STANDARD.** The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. **PROCEDURES.**
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
 - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
 - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
 - (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
 - (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
 - (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the

COR will contact the Contracting Officer for appropriate action under the Inspection clause.

I.2. PRICING DETAILS

This is a fixed price contract with additional option quantity. In case the quantity of drop point would increase or decrease Price would be negotiated again.
 Prices are expressed in the Local currency: Algerian dinars.

I.2.1. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period. The portions of the solicitation subject to VAT are all the services prices performed.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I.3 SCOPE OF WORK

The purpose of this fixed-price contract is to obtain refuse, waste, garbage and debris removal services from U.S. Embassy chancery and the U.S. Embassy leased properties in Algiers Wilaya, specifically the Ben Aknoun, El Biar, El Mouradia, and Hydra areas.

The Contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

I.3.1. GENERAL REQUIREMENTS

The removal of all garbage, refuse, waste and debris from U.S. Embassy Algiers properties are an important part of the representational and health and safety responsibilities of the U.S. mission. The U.S. Government will measure the Contractor's work by the general appearance of the garbage collection sites. The Contractor shall perform complete waste, garbage, debris removal services as described in this contract for all Government properties listed at NTP and subsequent additions and subtractions. The Contractor shall provide and include all personnel, equipment, planning, administration, and management necessary to assure that all services comply with the contract, the COR's schedules and instructions, and all applicable laws and regulations. The Contractor shall meet all of the standards of performance identified in the contract. The Contractor shall perform all related support functions such as supply, subcontracting, quality control, financial oversight, and maintenance of complete records and files. The contractor shall prepare general instructions for the work force.

I.3.2. Duties and Responsibilities

I.3.2 1. Contractor shall collect garbage from a single collection point on the U.S. Embassy compound and various leased residential properties. Collection will take place on pre-determined days. Garbage will be collected three (3) times per week from the Embassy compound, and two (2) time per week from the residential locations. Garbage will be collected from designated garbage containers at collection sites on the properties.

I.3.2 2. The total volume of the garbage to be collected by week is 50 M3 and may increase or decrease by 5 M3 maximum if the number of Residences increase.

I.3.2 3. Garbage: Garbage containers may include garbage, debris, garden / yard waste, organic waste, boxes, containers, recyclable materials etc. All garbage is to be removed from each garbage container.

I.3.2 4. Container Cleanliness. The contractor shall ensure that all garbage containers are free of all garbage upon completion of work. Loose garbage must be removed and disposed of during scheduled pickups. Contractor shall ensure odors from dirty containers are prevented.

I.3.2 5. All garbage containers will be lined with plastic bags of suitable size. The contractor will replace all bags after each garbage pickup.

I.3.2 6. Spillage. The Contractor shall pickup all spillage around collection sites within a ten (10) foot radius. The cleanup operation shall be concurrent with scheduled collections. The Contractor shall ensure that vehicle bodies are kept covered at all times to prevent loose garbage from blowing off.

I.3.2 7. The Embassy may require the Contractor to perform occasional services for the removal of work or Garden Garbagees (wooden, trees, cement...), tires, oil, batteries disposal... Or Medical waste. The Contractor should quote the occasional service separately with a one disposal trip unit price for each type of Items.

I.3.2. 8. The Embassy may require the Contractor to perform occasional services for the recycling, the contractor should provide a proposal for the recycling and quote a unit price for this service separately.

I.3.2. 9. The Contractor could also propose incineration services for Paper hard copy documents if service

I.3.3. MANAGEMENT AND SUPERVISION

I.3.3.1. SUPERVISION. The Contractor shall designate as many supervisors as necessary, but at least one, who shall be responsible for on-site supervision of the Contractor's workforce at all times. These supervisors shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. Supervisor(s) shall inspect all work areas to confirm that all necessary work was completed in a correct way.

I.3.3.2. SCHEDULES. The Contractor shall maintain work schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. The Contractor shall deliver standard services between the hours of 7:00 AM and 4:30 PM Sunday through Thursday. For those items other than routine daily services, the Contractor shall provide the COR with a detailed plan as to the personnel to be used and the time frame to perform the service.

I.3.3.3. QUALITY CONTROL. The Contractor, not the Government, shall be responsible for quality control and meeting of the terms of this contract. The Contractor shall perform inspection visits to the work site on a regular basis. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved, and the COR will conduct surprise inspections.

I.3.4. MATERIALS AND EQUIPMENT. The Contractor shall provide all necessary garbage removal supplies and equipment, including but not limited to vehicles, containers / bags, ladders, brooms, uniforms, gloves, shoes, etc. to perform the work identified in Section II. The contractor is advised to use any kind of equipment that is approved by the city administration and is safely used for job performance.

I.3.4. ACCESS.

I.3.4.1. The garbage collection points will be immediately outside the U.S. Embassy Algiers leased properties. Residents will be responsible for placing garbage curbside for pickup by the contractor in accordance to the published schedule. It is very important that the contractor adhere closely to the schedule in order to minimize the time that garbage remains outside the property.

I.3.5. WORKING HOURS. All work shall be performed on the two pre-determined days (Sunday – Thursday) from 7:00AM to 4:30PM except for the holidays identified in the Section II: Contract Clauses 652.237-72. Other hours may be approved by the COR. The Contractor must provide at least 24-hour advance notice to the COR who will consider any deviation from the hours identified above.

I.3.6. DELIVERABLES. The following items shall be delivered under this contract:

I.3.7. INVOICES AND PAYMENT: The Contractor shall provide a monthly invoice to the COR detailing all work completed. After routine inspections by the COR, if all work is deemed to be performed according to this contract, the invoice will be paid within 30 days from the date of invoice submission.

I.3.8. PERSONNEL REQUIREMENTS.

I.3.8.1. The U.S. Government is committed to promoting the fair and equitable treatment of all workers. In addition to adherence to the laws and regulations stated in I.17, the Contractor must pledge to be socially responsible by providing wages, benefits, and ethical treatment to its employees that go beyond the minimum required by local law, and demonstrate a commitment to a work environment befitting of a company contracted by the U.S. Government.

I.3.8.2. The Contractor shall employ sufficient personnel to maintain appropriate staff levels at all times. The Contractor shall have on reserve adequate personnel to cover any absences, ensuring there is no break in or deterioration of service at any location.

I.3.8.3. Contractor employees shall be on site only for duties related to this contract and not for any other business purposes. The Contractor shall maintain discipline at the properties and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on sites. The Government reserves the right to direct the Contractor to remove an employee from worksites for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional expense to the Government.

I.3.9. STANDARD OF CONDUCT

I.3.9.1. Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the COR that clearly identify them as employees of the Contractor.

I.3.9.2. Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty and ensure that unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security are not tolerated.

I.3.9.3. Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities, which interfere with normal and efficient Government operations.

I.3.9.4. Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

I.3.9.5. Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- i Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
- ii Unauthorized use of Government property, theft, vandalism, or immoral conduct; iii Unethical or improper use of official authority or credentials;
- iv Security violations; or,
- v Organizing or participating in gambling in any form.

I.3.10. KEY CONTROL. The Contractor shall not have access or keys to any of the properties.

I.3.11 NOTICE TO THE GOVERNMENT OF LABOR DISPUTES. The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

I.3.11 PERSONNEL SECURITY

I.3.11.1. Five (5) days after award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project, including enough alternates. The Government will run background checks on these individuals. It is anticipated that security checks will take approximately 60 days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- National Identification number

I.3.12. INSURANCE

The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this contract, all general liability and workers compensation insurance that is legally required under Algerian law. The Embassy may request proof insurance at any time prior to or after award of the contract.”

I.3.13. LAWS AND REGULATIONS

I.3.13. 1. Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. If there is a conflict between the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

I.3.13. 2. The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, unless they are inconsistent with the requirements of this contract.

I.3.14. QUALITY ASSURANCE. This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the

terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14.
